You need to have a good grasp of the English language so you can participate in the course. However, we do not need proof of this. So no need for IETLS, TOEFL or similar.
2	Why is Albania excluded from the eligible country list?	Eligibility can be checked on these pages: OKP and MSP The scholarship programme is funded by the Ministry of Foreign Affairs. They decide the eligible country list and Nuffic and WCDI have no control over this.

4	Why is an unemployed applicant with strong motivation not eligible?	Because the way NUFFIC/Ministry of Foreign Affairs has set up this scholarship, the knowledge gained in the courses, need to be shared with others within your organisation. If you are unemployed, you are not able to share this

Because of COVID it's hard to travel to get a stamp or signature, a signature is allowed to deliver digitally for the Employer statement. 6	Is it a must to have a government statement?	That depends on the country, you can visit the government statement requirements list (OKP and MSP) to see whether your country needs a government statement
7	I got a mail asking me to prepare documents but not the registration letter. What do I do next?	It might be possible that you did not receive your registration letter, please send an e-mail (to training.cdi@wur.nl) with your details so we can re-send the registration letter.

Unfortunately, not. Our management team lobbied with NUFFIC for this option but didn't manage to arrange it. Tip: maybe work from a different location, such as coffee shop or hotel lobby.

We cannot give examples or ideas for this section. Make sure to fill in these gaps as relevant/specific as possible keeping in mind the course you are applying for. And think about country focus.

Is there any other way an applicant can be tested on his/her English proficiency throughout the application process and not immediately rejected due to that he/she is not presenting the certificate?	You do not need to submit a certificate to prove your English proficiency level. Please do note that it is important that you have a sufficient grasp of the English language, but we hope to see this back in your application.
11	What is the strategic importance of these short scholarships?	Each country has a country focus which they would like to see developed (such as fisheries, agriculture). Countries assign scholarships to persons who relate to the country focus. For the WCDI short courses, we do expect you to have a certain level of English to participate in our courses. However, you don't need to hand in a certificate or diploma proving your level of English.
