The Nagoya Protocol is meant to create incentives for the fair and equitable sharing of benefits arising from the utilization of genetic resources and traditional knowledge. However, stakeholders assess it as an obstacle rather than an incentive for commercial activities.

The workshop aims to explore the potential of private standards in addressing this challenge by creating a positive driver for benefit sharing under the Nagoya Protocol. Together with invited participants, we want to debate whether consumer-targeted labels on products can support value creation in relevant supply chains in different sectors. Can private standards serve to valorise the Nagoya Protocol, and turn it from an obstacle into an opportunity?
