Introduction to the Report: visit at the COP26 as a key event of the incubator project "Science without jargon at the COP26"

Academics and practitioners complement each other on tackling sustainability challenges; however, despite working in the same field, they often use different technical terms (jargon) and perspectives that make communication between them difficult. To tackle this challenge a group of researchers form WCSG cluster has started an incubator project call Sustainable governance talks without jargon. The goal of this incubator is to promote two-way communication between academics and practitioners is essential to promote innovation. The "Sustainable Governance Talks Without Jargon" project wants to help PhD candidates bridge this gap by fostering *jargon-free* communication with practitioners. At the same time, by using a common language, PhDs can share their research with a wider audience.

The Sustainable Governance Talks Without Jargon supports WCSG PhDs to develop skills to communicate beyond academia, connect with practitioners related to their research, and develop nonacademic publications to reach a wider audience. By doing so, the scientific impact of the research of PhDs can be enhanced through more connection with practitioners and society in general and the contacts between scientists and practitioners can be the starting point for further collaborations. With this mission of incubator project, a team of PhD from SSG applied to participate in the COP26 in Glasgow, and two delegates of ENP- Helena Solman and Robin Smale went to the COP26 and represented the incubator team. They went for the second week of COP26 between 7-Nov-2021 till 11-Nov-2021. The COP26 was chosen as a main event for the incubator activity talks without jargon because it is where world leaders as well as range of practitioners form the private sector, activists and academics come together to discuss and act upon the urgency of climate change. This is an important event where science can be linked to practice, for societal impact and environmental sustainability. Therefore, the COP26 offers a unique possibility to engage with policy makes and practitioners working in governance of sustainability challenges across the world but the whole event is geared towards mutual learning and networking. Taking this opportunity, a range of activities and events were organised in the light of the key theme "Science Talks without Jargon." These included:

- **1. Panel discussion "Science without Jargon"** bridging the gap between research on energy transition, climate finance and local energy governance with practice a discussion between the participants of incubator project Helena Solman and Robin Smale, associated ENP PhD Robert Bergsvik and Dr Mark Bynoe speaking on behalf of Caribbean Community Climate Change Centre (CCCCC)
- **2. Press Conference Climate Talks Without Jargon:** livestreamed and online available discussion by a team of researcher (including the two representatives of the incubator project (Helena Solman and Robin Smale at COP26) about their reflections related to the COP26. Summary of the session:

This panel discussed the topic of NSAs (non-state actors) engagement in climate change. The panel was conducted in a "jargon-free" format, one that encouraged discussion and exchange about translating the findings from academic research into the everyday work of experts and practitioners in the field of sustainability governance and climate change mitigation and adaptation specifically. By sharing lessons and experiences from several cases across the globe on these range of topics, the panel also provides a means to inform our academic research with the on-ground practices and challenges. The topics discussed are the proposed topics:

- 1. Citizen participation in the energy transition and climate policy in Wageningen, the Netherlands- Robin Smale (speaking about his PhD research on smart grids as well as experiences as policy maker at the municipality of Wageningen)
- 2. Public concern and resistance as a key challenge in energy transition by Helena Solman, presenting insights from her research about opposition to wind power
- 3. The role and politics of climate finance agreements on climate adaptation and mitigation by Robert Bergsvik, presenting his research about politics of climate finance at the COP
- 4. Examples of good practices in the implementation of climate mitigation and adaptation projects in the Caribbean region. Dr. Mark Bynoe speaking on behalf of Caribbean Community Climate Change Centre (CCCCC)

A diversity of perspectives brought by panellists from various background of academia, non-profit and government sector will provide an insightful and integrative view on the topics.






2. Press conference Climate Talks Without Jargon: Researchers from Wageningen University at COP26 share insights
